



### DMISSIONS REQUIREMENTS

**Freshman:** High school diploma, GED, or equivalent completion of secondary school.

**Transfer:** Overall GPA of 2.0 (Engineering and Allied Health programs require an overall GPA of 2.5 or higher). For more information contact the Office of Admissions at (718) 319-7900 or visit our website at www.hostos.cuny.edu.

Faculty: The faculty at Hostos come from diverse educational backgrounds. More than half of the full-time faculty holds doctorate degrees. The student faculty ratio is 18:1, which creates an atmosphere of trust and openness among students and faculty.

# FORMAL REPORT OF THE COMMISSION ON DENTAL ACCREDITATION TO THE ADMINISTRATION OF EUGENIO MARIA DE HOSTOS COMMUNITY COLLEGE ON THE EVALUATION OF THE DENTAL HYGIENE EDUCATION PROGRAM

Bronx, New York\*

### Introduction

An evaluation of the dental hygiene program offered by Eugenio Maria De Hostos Community College was conducted on September 20-21, 2011 by a committee of the Commission on Dental Accreditation composed of Ms. Janella Spencer, consultant in dental hygiene; and Ms. Tami Grzesikowski, Commission staff representative.

The Commission believes that educational institutions offering curricula supportive to the dental profession assume the obligation and responsibility of affording quality educational opportunities which are based on sound educational principles. Commission objectives are also based on the premise that dental hygiene education programs should strive continually to improve standards of scholarship and teaching consistent with the purpose and methods of postsecondary education. To assist the institution in appraising its educational effectiveness and identifying ways and means by which its endeavors can be strengthened, dental hygiene programs are reviewed periodically by peers in relation to predetermined standards. This peer review of the educational process is based on the program's self-study and conferences with persons involved in the various components of the program.

This report represents the visiting committee's findings and conclusions in the form of recommendations and a suggestion that directly relate to accreditation standards for program improvement and enhancement. These are found, as appropriate, under headings that parallel the Commission's Accreditation Standards for Dental Hygiene Education Programs. The recommendations are indented and numbered sequentially throughout the report. Only those standards that warrant one of the aforementioned types of comments are included; in all other cases, the visiting committee found that the program met or exceeded the minimum standards.

The Commission on Dental Accreditation has discontinued the use of commendations, effective July 26, 2007. As a result, commendations will no longer be cited within site visit reports for programs under the Commission's purview.

### **Accreditation History**

The dental hygiene program offered by Eugenio Maria De Hostos Community College was initiated in 1970. This was the Commission's eighth site evaluation of the dental hygiene program. At the time of the site visit, the accreditation status for the dental hygiene education

### Review of Recommendations Cited in the Program's Previous Site Visit Report

At the time of the Commission's last evaluation of the program in April 2004, five

recommendations were cited in the areas of Institutional Effectiveness, Educational Program and Administration, Faculty and Staff. During this evaluation, the visiting committee reviewed these areas and found that the program has maintained compliance with the previously cited recommendations.

### **Compliance with Commission Policies**

At the time of the site visit, the visiting committee determined that the program was in compliance with the Commission on Dental Accreditation's policies on "Third Party Comments" and "Complaints."

### **Standard 1. Institutional Effectiveness**

The program has documented its effectiveness using a formal and ongoing outcomes assessment process to include measures of dental hygiene student achievement.

### Standard 2. Educational Program

The dental hygiene program is presented in four, 15-week terms and one, 7-week summer term. Upon completion of the program, graduates are awarded associate in applied science degrees. The curriculum has been defined in terms of program goals, general instructional objectives, learning experiences designed to achieve the goals and objectives and evaluation procedures to assess student attainment of the goals and objectives.

The dental hygiene program must have established mechanisms to ensure a sufficient number of patient experiences that afford all students the opportunity to achieve stated competencies. Through on-site review of the documents, the visiting committee noted that the tracking system used by the program to monitor each student's patient care experiences, indicated that some, but not all, students receive patient experiences with all patient categories. Some students do not meet the program's requirements for the child and geriatric patients as well as sealants and radiographs. Therefore, the visiting committee was unable to verify that all students have the opportunities to achieve stated competencies.

1. It is recommended that the dental hygiene program must have established mechanisms to ensure a sufficient number of patient experiences that afford all students the opportunity to achieve stated competencies. (DH Standard 2-15)

Graduates must be competent in providing dental hygiene care for the child, adolescent, adult and geriatric patient. Graduates must be competent in assessing the treatment needs of patients with special needs. An appropriate patient pool should be available to provide a wide scope of patient experiences that include: children, adolescent, adults, geriatric and special needs patients.

Through review of the self-study documents and on-site interviews, the visiting committee learned that students have a variety of clinical experiences which includes children, adults and patients with special needs. However, it was determined that although students are required to complete two geriatric patients, there were multiple students who did not satisfy this requirement prior to graduation. Therefore, the visiting committee was unable to verify that all graduates are competent in providing dental hygiene care for the geriatric patient.

2. It is recommended that graduates be competent in providing dental hygiene care for the geriatric patient. (DH Standard 2-16)

To assure the incorporation of updated information, appropriate sequencing, the elimination of repetition, and the attainment of student competence, a formal curriculum review process should be conducted on an ongoing and regular basis. The dental hygiene program has a formal, written curriculum management plan which includes curriculum review and an evaluation process with input from faculty, students and administration. However, through on-site interviews, it was determined that the program does not collaborate with general science faculty nor conduct employer satisfaction surveys. It is suggested that the program review its curriculum management plan and revise it as appropriate to include all components of the Standard 2-26.

### Standard 5. Health and Safety Provisions

The program must document its compliance with institutional policy and applicable regulations of local, state and federal agencies including, but not limited to, radiation hygiene and protection, ionizing radiation, hazardous materials, and bloodborne and infectious diseases. Policies must be provided to all students, faculty, and appropriate support staff, and continuously monitored for compliance. Policies on bloodborne and infectious diseases must be made available to applicants for admission and patients.

Upon review of self-study documents, review of on-site materials and on-site interviews, it was determined that policies on bloodborne and infectious diseases were not available to applicants for admission or clinic patients.

3. It is recommended that policies on bloodborne and infectious diseases are made available to applicants for admission and patients. (DH Standard 5-1)

### **Standard 6. Patient Care Services**

The program must have a formal written patient care quality assurance plan and should have a system in place for continuous review of established standards of patient care. Upon review of the self-study document and on-site interviews, the visiting committee noted that a survey, Quality of Service, is conducted each semester. Additionally each semester, an audit is conducted on twenty-five randomly selected patient charts. The Quality Assurance Audit Form used during the chart audits does not include a review of the care provided or maintenance and

referral information. The visiting committee determined that a procedure to review treatment outcomes and implement corrective measures had not been established. Therefore, it could not be verified that there is a continuous review of established standards of patient care.

4. It is recommended that the program have a formal written patient care quality assurance plan that includes patient review policies, procedures, outcomes and corrective measures. (DH Standard 6-2,d)

### **Accreditation Status**

At its February 2, 2012 meeting the Commission on Dental Accreditation adopted a resolution to continue the accreditation status of "approval <u>without</u> reporting requirements" for the dental hygiene program offered by Eugenio Maria De Hostos Community College.

### ACCREDITATION STATUS DEFINITIONS

### PROGRAMS WHICH ARE FULLY OPERATIONAL

APPROVAL (without reporting requirements): An accreditation classification granted to an educational program indicating that the program achieves or exceeds the basic requirements for accreditation.

APPROVAL (with reporting requirements): An accreditation classification granted to an educational program indicating that specific deficiencies or weaknesses exist in one or more areas of the program. Evidence of compliance with the cited standards must be demonstrated within 18 months if the program is between one and two years in length or two years if the program is at least two years in length. If the deficiencies are not corrected within the specified time period, accreditation will be withdrawn, unless the Commission extends the period for achieving compliance for good cause.

(Adopted: 01/98)

### PROGRAMS WHICH ARE NOT FULLY OPERATIONAL

A program which has not enrolled and graduated at least one class of students/residents and does not have students/residents enrolled in each year of the program is defined by the Commission as "not fully operational." The accreditation classification granted by the Commission on Dental Accreditation to programs which are not fully operational is "initial accreditation." When "initial accreditation" status is granted to a developing education program, it is in effect through the projected initial enrollment date. However, if enrollment is delayed for two consecutive years, the institution must reapply for "initial accreditation" and update pertinent information on program development. Following this, the Commission will reconsider granting "initial accreditation" status.

Initial Accreditation: Initial Accreditation is the accreditation classification granted to any dental, advanced dental or allied dental education program which is in the planning and early stages of development or an intermediate stage of program implementation and not yet fully operational. This accreditation classification provides evidence to educational institutions, licensing bodies, government or other granting agencies that, at the time of initial evaluation(s), the developing education program has the potential for meeting the standards set forth in the requirements for an accredited educational program for the specific occupational area. The classification "initial accreditation" is granted based upon one or more site evaluation visit(s) and until the program is fully operational.

(CODA: 02/02; Revised 07/08)

### **Initial Accreditation Status for Accredited Programs**

An additional purpose of accreditation recognized by the United States Department of Education (USDE) is the protection of the public through the identification of qualified personnel to staff the health care system. Therefore, the Commission on Dental Accreditation established accreditation classifications, which have proven to be acceptable to educational institutions. Published definitions are a widely recognized means for carrying out accreditation functions.

"Initial Accreditation" status is an accreditation classification that is applicable to developing programs. It is granted when a proposed or developing program demonstrates that it has the potential to meet the accreditation standards.

For this reason, the Commission is firm in its policy that the developing program must not enroll students/residents until "initial accreditation" status has been obtained. If a program enrolls students/residents without first having been granted "initial accreditation" status, the Commission will notify all students/residents enrolled of the possible

ramifications of enrollment in a program operating without accreditation. The Commission will also notify the applicable state board of dentistry.

When "initial accreditation" status is denied and the program wishes to reapply, it is the responsibility of the institution to make use of all possible resources, including consultation with the Commission on Dental Accreditation. (Refer to the Policy on Public Disclosure and Confidentiality for additional information regarding the announcement of an action to deny accreditation).

### **OTHER ACCREDITATION ACTIONS**

**Discontinued:** An action taken by the Commission when a program voluntarily discontinues its participation in the accreditation program and no longer enrolls a first year class.

Intent to Withdraw: A formal warning utilized by the Commission on Dental Accreditation to notify an accredited program and the communities of interest that the program's accreditation will be withdrawn if compliance with accreditation standards or policies cannot be demonstrated by a specified date. The warning is usually for a six-month period, unless the Commission extends for good cause.

### "Intent to Withdraw" Accreditation

In the event accreditation is withdrawn from a program by the Commission, students currently enrolled in the program at the time accreditation is withdrawn and who successfully complete the program will be considered graduates of an accredited program. Students who enroll in a program after the accreditation has been withdrawn will not be considered graduates of a Commission-accredited program. Such graduates may be ineligible for certification/licensure examinations. In view of this, the Commission advises programs that the "intent to withdraw" accreditation may have legal implications for the program and suggests that their institutional legal counsel be consulted regarding how and when to advise applicants and students of the Commission's accreditation actions.

Withdraw: An action taken by the Commission when a program has been unable to demonstrate compliance with the accreditation standards or policies within the time period specified. A final action to withdraw accreditation is communicated to the program and announced to the communities of interest. A statement summarizing the reasons for the Commission's decision and comments, if any, that the affected program has made with regard to this decision, is available upon request from the Commission office. In the event the Commission withdraws accreditation from a program, students currently enrolled in the program at the time accreditation is withdrawn and who successfully complete the program, will be considered graduates of an accredited program. Students who enroll in a program after the accreditation has been withdrawn will not be considered graduates of a Commission-accredited program.
